Purposes for which we process personal data	<p>The Club will process the personal data for:</p> <ul style="list-style-type: none">• Administering your application for membership of the Club• Administering bookings and attendance at sessions• Dealing with medical needs/specific requirements• Supporting the delivery of cricket sessions• Training and competition entry• Reporting of participation and any incidents and of figures and trends (including equality and inclusion information)• Quality and improvement monitoring• Ensuring compliance with cricket regulations and with club and ECB policies including the ECB Recreational Cricket Safety Regulations and ECB Safe Hands Policy and the ECB Disparity Regulations• Safeguarding purposes• Dealing with enquiries and any claims or proceedings
Who we may disclose your personal data to	<ul style="list-style-type: none">• Leagues where you have been nominated for / agree to play for a League• The ECB where you are registered for or express an interest in an ECB programme• The County Cricket Board, Recreational Cricket Boards and professional County Clubs.

Legal basis for processing your personal data	<p>The legal basis for the collection and processing of your personal data is:</p> <ul style="list-style-type: none"> • for administration and programme delivery: that it is necessary to fulfil the contract that you are going to enter into or have entered into with us • for dealing with medical needs: that you have given your explicit consent or it is in your vital interests.] • in all other cases: that it is necessary for our legitimate interests or those of the ECB which are to build a programme to encourage participation in cricket and this does not prejudice or harm your rights and freedoms of members, parents, carers, or the children that join the programme. • Safeguarding: that it is necessary to safeguard children and individuals at risk. • For insurance purposes: that it is necessary for insurance purposes. • Claims / proceedings: that is it necessary for the establishment, exercise or defence of legal claims.
Your right to withdraw consent	Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.
Location of your personal data	The Club will keep your personal data within the United Kingdom or European Economic Area.
How long we will keep your personal data for	<p>We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with DTCC as a member.</p> <p>2 years after you cease to be a member of DTCC or play an active part in DTCC, we shall delete your data excepting that needed to keep historical scorecard and statistical records.</p>
Your rights in respect of your personal data	You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.
